
3.	Based on these passages, how would you succinctly define or describe Christian community?		
4.	The picture of Christian community presented in Scripture is, in many ways, a far cry from what we see today – especially given contemporary American culture. Consider the cultural attributes discussed below.		
		Individualism: This is the degree to which an individual is expected to look out primarily for personal interests (individualism) versus the interests of a larger group (collectivism). The United States ranks high in individualism, to the point that Barna Research notes that 56% of American adult Christians consider their spiritual life entirely private. How do you see this play out today?	
		Compartmentalization: This is the tendency to separate the spiritual from the secular, to establish barriers in life and experience within which faith applies and outside of which faith has little place. How can such a separation be harmful to one's Christian walk? How can Christian community help address this?	
	a.	Digitally-mediated relationships: Today the world is more mobile and in-touch than ever before. And yet, many Americans feel more isolated than ever, suggesting that it's not only connection that matters, but the <i>quality</i> of the connection. "The medium makes a difference," asserts Michael Horton. Do you agree? What are some applications to Christian community?	
	b.	Consumerism: This can be defined as a preoccupation with acquisition to satisfy personal needs or wants. As consumer goods have proliferated in modern society, so too has a consumeristic mindset – and Christians aren't immune. Come up with at least three ways or examples in which consumerism negatively influences the Christian community Scripture encourages.
